ILLINOIS SPORTS FACILITIES AUTHORITY RESOLUTION 15-05

A RESOLUTION APPROVING REIMBURSEMENT FOR CERTAIN CAPITAL IMPROVEMENTS TO BE UNDERTAKEN BY THE CHICAGO PARK DISTRICT AND THE REQUEST OF ADDITIONAL FUNDS FROM THE SOLDIER FIELD CAPITAL IMPROVEMENT FUND BY THE CHICAGO PARK DISTRICT

WHEREAS, pursuant to the Operation Assistance Agreement (the "Agreement"), dated as of August 1, 2001, between the Illinois Sports Facilities Authority (the "Authority") and the Chicago Park District (the "Park District"), the Park District previously submitted to the Authority its annual one-year plan of proposed Capital Improvements (as defined in the Agreement) to be undertaken by the Park District at Soldier Field (the "One-Year Plan") and the Authority reviewed the One Year Plan; and

WHEREAS, the Agreement provides that the Authority will reimburse the Park District from funds available in the Authority's Soldier Field Capital Improvement Fund (the "Capital Improvement Fund") for each Capital Improvement set forth in the One-Year Plan, if each such improvement is a Capital Improvement pursuant to the Agreement and is located on the Site (as defined in the Agreement); and

WHEREAS the Agreement further provides (pursuant to Section 4.6) that amounts deposited in the Capital Improvement Fund but not paid to the Park District during any Permit Year (as defined in the Agreement) shall remain in the Capital Improvement Fund and be available for requisition by the Park District in subsequent Permit Years throughout the term of the Agreement.

NOW, THEREFORE, BE IT RESOLVED, by the members of the Illinois Sports Facilities Authority as follows:

- **Section 1.** The Authority has reviewed the One-Year Plan and approves reimbursement for the Capital Improvements requested by the Park District as identified in Exhibit A (the "Approved Capital Improvements"). The Authority authorizes the Board Chairman, Chief Executive Officer or Chief Financial Officer of the Authority to reimburse the Park District in an amount not to exceed \$2,813,773 (plus interest earnings, if any, on such amount available in the Capital Improvement Fund) in total for all such Approved Capital Improvements from amounts on deposit in the Capital Improvement Fund, upon submission of the documentation by the Park District required by the Agreement.
- **Section 2.** The Authority has received the Park District Additional Funds Request Letter dated February 1, 2015, as identified in Exhibit B (the "Request Letter") and approves the request for additional funds for the Scoreboard–Control Room and the Scoreboard-Control Room project shall be an Approved Capital Improvement in addition to the other Approved Capital Improvements. The Authority authorizes the Board Chairman or the Chief Executive Officer of the Authority to reimburse the Park District in an amount not to exceed \$2,000,000 from amounts on deposit in the Capital Improvement Fund, upon submission of the documentation by

the Park District required by the Agreement, such funds which are available for requisition by the Park District in subsequent Permit Years throughout the term of the Agreement.

Section 3. The Board Chairman, Chief Executive Officer or Chief Financial Officer of the Authority are hereby authorized to perform all acts and deeds on behalf of the Authority to implement this Resolution.

Section 4. This Resolution shall take effect immediately upon its adoption.
