Determination and Declaration by the Chair of the Illinois Sports Facilities Authority

I, Manuel Sanchez, as the Chair of the Illinois Sports Facilities Authority (the "Authority"), hereby make the following determination and declarations:

THAT the Governor of the State of Illinois has issued a Gubernatorial Disaster Proclamation that, pursuant to the provisions of the Illinois Emergency Management Agency Act, a disaster exists within the State of Illinois related to public health concerns caused by Coronavirus Disease 2019 and declaring all counties in the State of Illinois as a disaster area, which proclamation remains in effect.

THAT in accordance with the provisions of Section 7(e) of the Open Meetings Act, as amended, I have determined that an in-person meeting of the Authority on September 17, 2020, the next regularly scheduled meeting of the Authority, is not practical or prudent because of the disaster declared by the Governor; and

THEREFORE the next regular meeting of the Authority scheduled for September 17, 2020 at 10:00 a.m. shall be conducted virtually, without the physical presence of a quorum of the members, in accordance with the provisions of Section 7(e) of the Open Meetings Act, as amended; and

THAT all members of the body participating in the meeting, wherever their physical location, shall be verified and can hear one another and can hear all discussion; and

THAT all members of the public present at the meeting location of the body can hear all discussion and all votes of the members; any interested member of the public will be provided access to contemporaneously hear all discussion and roll call votes; and

THAT the Chair of the Authority shall be physically present at the meeting location.
